

TERMS AND CONDITIONS OF HEALTH CLUB MEMBERSHIP

Suspension **Minimum Period - 1 Month / Maximum Period - 12 Months**

Only memberships that have suspension privileges may be suspended. A suspension form must be completed by the member prior to the period of absence otherwise the suspension will not be valid. In the case of temporary physical incapacity* that is validated by a medical certificate, no cost will be incurred by the member for the suspension. A letter and copy of the certificate should be supplied in person or by fax to 4903 6250. All other suspensions will incur a fee of \$0.33 per day + a \$15 administration fee. Suspensions will not be back dated. The period of the suspension is added to the end of the membership term.

* A temporary physical incapacity is defined as an injury or ailment which prohibits the member from participating in any kind of physical activity offered by the Health Club.

Cooling Off **7 Days**

There is a seven (7) day cooling off period for all prepaid term memberships of three (3) months and longer. Any refund request must be in writing during the cooling off period and will be subject to a deduction of the administration fee and fees for the services received. Except for permanent physical incapacity, which must be validated by an official medical document, membership is non refundable for any other reason or circumstances, including but not limited to non-use, re-location, change of mind, or employment, too busy, health or personal problems. Where a refund is offered, the Health Club agrees that it will be paid in full within fourteen (14) days of its application being accepted. The \$25.00 administration fee is non-refundable.

Membership Card

Membership cards are not transferable** and must be shown on every visit to gain entry. Photo identification is necessary with Health Club Membership purchase and an id photo will be taken for the Health Club database records only. Members must get a replacement card if their card is lost or stolen at cost of \$2. These can be organised through either of our Club Help Desks or Balance Receptions.

**If a member has allowed his or her membership card to be used by another person for the purpose of obtaining admission, the person to whom the membership card was issued forfeits all claims and rights to the card and ceases to be a member and the card will be retained. Contract is then subject to full cancellation fees.

Privacy Act
